Description of the course

Throughout the lecture series, scholars from Ukraine will give presentations to foreign students at German universities on their current research. The topics will encompass a large spectrum of scientific interests to holistically represent research on the history of Ukraine. Each lecture will present a dimension of Ukrainian history – its people, values, traditions, characteristics, and identity. The lecture series will cover a large chronology – from ancient times to the events taking place in Ukraine today. Participants include archaeologists, historians, museologists, Ukrainian philologists, and representatives of public organizations. The topics presented will relate to unique archaeological sites, the history of archaeology as a science and important events in its history, the origins of Ukrainians, the formation of a national Ukrainian identity, the birth of Ukrainian independence, about archiving in Ukraine and the uniqueness of Ukrainian archives and world collections, the history of Kharkiv and modernization processes, the life of a university, the daily life of teachers and students, as well as the cultural heritage of Ukraine and the current situation with cultural monuments issues of war and peace, ethnic diversity in Ukrainian cities, propaganda, volunteer movements, and the full-scale Russian war against Ukraine.

Lecture 1: "Nomadic culture of the Early Iron Age in the East European foreststeppe"

Lecturer: Pelyashenko Konstantin, Candidate of Historical Sciences (PhD), Museum of Archaeology, V. N. Karazin Kharkiv National University. Senior researcher.

The Early Iron Age in the East European forest-steppe: Contacts of ancient nomads with local tribes in the 1st millennium B.C. The Early Iron Age of Eurasia was characterized by migration waves of nomads (Cimmerians, Scythians, Sarmatians) through the so-called "steppe corridor". In addition to the steppe zone, ancient nomads partially occupied the forest-steppe strip, where they came into contact with sedentary population and had a significant impact on their material culture. The following questions are addressed: What was the nomadic culture like, what were the antiquities connected to them and what was the nature of contacts between migrants and locals. The lecture is based on archaeological and written sources.

Lecture 2: Ancient ceramist and ethnicity: pottery of the ancient population of Ukraine.

Lecturer: Pelyashenko Konstantin, Candidate of Historical Sciences (PhD), Museum of Archaeology, V. N. Karazin Kharkiv National University. Senior researcher.

In archaeology, pottery is a very important and informative source. Characteristic features of ornamentation, morphology and technology of clay pottery production allow to identify ancient ethnic groups, to determine the genetic relationship of antiquities from different historical periods, to reconstruct the ways of migration of the ancient population. The lecture contains a brief excursus on the development of pottery of the ancient population of Ukraine, from the New Stone Age to the Middle Ages. It also introduces traditional and modern methods of research of ancient pottery.

Lecture 3: History of Ukrainian archeology: Main development trends (nineteenth to early twentieth century)

Lecturer: Irina Skirda, PhD, "Kharkiv College of Arts"

The history of Ukrainian archeology: the main development trends (XIX - beginning of XX century) Recently, the interest in the history of archeological science has been growing in the scientific community. It can be argued that today the history of archeology confidently positions itself as an









independent actively developing subdiscipline. This is evidenced, in particular, by annual international scientific conferences on relevant topics, which are held in Ukraine on the initiative of the Institute of Archaeology of NAS of Ukraine since 2010. Special historiographical sections are included in the programs of various scientific forums devoted to specific scientific problems of archaeology. One of the reasons, which actualized the interest to the history of Ukrainian archeology, is an unsatisfactory condition of historiography of archeology: its undeveloped theoretical foundations, the large number of "white spots" and "forgotten" names in the history of domestic archeology, which can not adequately assess the history of the science to identify trends and prospects for its development. This lecture is devoted to attempts of rethinking the main tendencies of development of Ukrainian archeology of XIX - beginning of XX century.

Lecture 4: XIIth Archaeological Congress in Kharkiv: A look back 120 years later.

Lecturer: Irina Skirda, PhD, "Kharkiv College of Arts"

XII Archaeological Congress (on the 120th anniversary): a page of the history of Ukrainian archeology. The lecture is devoted to one of the defining events in the history of Ukrainian archeology of the beginning of the XX century. - The XII Archeological Congress took place in Kharkiv in 1902 and became an important factor in development and formation of the Ukrainian historical science. Outstanding role in the history of domestic archeology and related branches of historical knowledge played archeological congresses, which were held in Ukraine. It was at them that topical general









theoretical and practical problems were discussed, the tasks of reforming scientific institutions were set, a process of creating professional "intellectual communities" was under way, channels of scientific communication were established, which eventually contributed to the discipline and institutionalization of archaeological/historical science.Out of 6 archaeological congresses, which took place in Ukraine, the most effective was XII Archaeological Congress, which was held in Kharkiv. In that connection arise questions: What factors determined the fruitful results of its work? What provided Kharkiv archaeological forum with such a public response? What scientific discoveries were made thanks to it? What was the influence of XII Archeological Congress on the further development of archeology and other historical disciplines? We will try to find answers to these and other questions during the lecture.

Lecture 6: Primary Research Results of the Medieval Archeological Expedition by the NUKh, V.N Karazin in the last years

Lecturer: Valeriy Skirda (PhD), lecturer at the department of histography, source studies, and archeology in the history faculty at the National University of Kharkiv, V.N. Karazin.)









The lecture will cover the exploration and excavations from a recent research expedition. Special attention will be paid to monuments from archeological sites dating back to the early Middle Ages (8th through 10th centuries). Primary points of reference will relate to the excavation of monuments eponymous to the archeological site. This includes the Verkhnesaltovsky catacombs and burial grounds, researched since 1900, as well as the burial grounds at the medieval Saltovsky site, discovered in 2019 near the village of Khotimlya. Further materials include information on the settlements discovered during the exploration. Of course, everything will be illustrated with photographs, charts, and drawings. The complexity of the presentation will depend on the audience.

Lecture 7: Archiving i Ukraine: History, system of institutions, priorities for action

Lecturer: Anna Alekseyenko, Candidate of Historical Sciences, Archivist Central State Scientific and Technical Archive of Ukraine.

"Archiving in Ukraine: History, System of Institutions, Priorities of Activity". The lecture reveals the history of archival science in Ukraine, from the first attempts at institutionalization and creation of the archival-library department of the Ministry of Education of the Ukrainian People's Republic in 1918 to the last changes after the archival reform in 2022. The main ideas and activities of the









founders of the Ukrainian archival system, Oleksandr Hrushevskyi, Vadym Modzalevskyi, etc., will be analyzed. The main stages of the development of the archival institutions system will be distinguished, and attention will be focused on the significance of their separation from the NKVD administration in 1961, the adoption of a special archival law after Ukraine gained its independence, and modern understanding of the National Archives Information Resources. Main components of the Ukrainian archival institutions system, their tasks and functional distribution in their activities will be characterized.

Lecture 9: Formation of the Modern Ukrainian Nation

Lecture 10: World War II in the contemporary Ukrainian discourse

Lecturer: Igor Dvorkin (PhD), lecturer at the department of Ukrainian Studies at the National Technological University "Polytechnical Institute of Kharkiv")

In 2022, with the outbreak of a full-scale Russian-Ukrainian war, the interest in history in the public significantly increases interest in history. Of course, this also applies to the previous destructive war on the territory of modern Ukraine - the Second World War. People who are experiencing the horrors of war today often turn to the family memory and experience of their ancestors who fought, evacuated

At the state level, at the level of collective and family memory, on the streets and squares of Ukrainian cities, at school and university, the Second World War II was and remains present.

Lecture 11: Genocide as a phenomenon in world history: theoretical framework.

Lecturer: Volodymyr Zelinski, PhD, specialised in historiography, source studies and special historical disciplines, assistant at the Department of History, Museology and Cultural Heritage, National University "Lviv Polytechnic"

The persecution of people on racial, ethnic, national, religious or any other characteristic with the aim of fully or partially destroying that group is the crime of genocide. Unfortunately, such events have occurred on numerous occasions in world history. Today, under international law, genocide is a crime punishable by severe penalties. Therefore, it is important to understand the nature of its emergence, the preconditions for radicalisation of violence, the mechanisms of prevention and the consequences of this crime. Hence, the importance of studying theoretical aspects, namely the legal definition,









issues of genocidal intent, sociology and anthropology of genocide, psychological aspects, denial of genocide, prevention strategies.

Lecture 12: The Holocaust on the territory of the District of Galicia (1941-1944).

Lecturer: Volodymyr Zelinski, PhD, specialised in historiography, source studies and special historical disciplines, assistant at the Department of History, Museology and Cultural Heritage, National University "Lviv Polytechnic"

Soon after the outbreak of war on 22 June 1941, the District of Halychyna was proclaimed (1 August 1941) on a large area of western Ukraine that had been overrun by the Nazis. It became the heel administrative unit in the Governor General's Office and was abolished at the end of July 1944. The extermination of the Jews took place throughout the whole period of the occupation. More than half Off-University firmly takes a stance against discrimination, harassment, exploitation, or intimidation.









a million Galician Jews died as a result of Nazi policy. Although Galicia had been officially proclaimed Judenfrei (German for "free of Jews") as far back as June 23rd, 1943, there were still murders of people who were still in forced labor camps, in prison or hiding in the woods until the middle of summer 1944.

Lecture 13-14: Soviet policy of Russification of Ukraine: changes in ethnic and linguistic composition of the population in 1959-1989.

Lecturer: Vladimir Sklyar (Doctor of history, professor at the department of Ukrainian Studies at the National Technological University "Polytechnical Institute of Kharkiv")









Changes in the ethnic composition and language structure of the population of Ukraine were determined based on the processing of statistical materials of the population censuses of 1959, 1970, 1979, and 1989. On the basis of statistical materials, it has been proven that for 30 years there has been an intensive increase in the number of Russians and the Russian-speaking population, especially in the eastern and southern regions, primarily in the urban environment of Donbass and Crimea. On the contrary, during this time, the share of Ukrainians and the Ukrainian-speaking population among the total population of Ukraine decreased. That is, there was a gradual Russification of Ukraine, primarily of its urban environment. The Russian ethnic minority in Ukraine's statelessness occupied a dominant position, while the Ukrainians found themselves in the position of a subordinate majority. That is why there was a mass population of Russians in Ukraine and an unnatural linguistic and ethnic assimilation of Ukrainians.

Lecture 17: The challenge of modernization or how the problem of rubbish was solved in the provincial city of Kharkiv (2nd half of 19th - beginning of 20th century)

Lecturer: Khovtun Anastasia, Ph.D., , Faculty of History, V. N. Karazin Kharkiv National University

"The challenge of modernization or how the problem of rubbish was solved in the provincial city of Kharkov (second half of XIX - beginning of XX century)". The lecture analyzes the formation of the practice of waste disposal in Kharkov. At the end of the 19th century, clearing city space was mainly the responsibility of landlords. The second half of the XIX century was the time of rapid increase in population and rapid industrial development. Researchers of Ukrainian urban history do not often pay attention to the fact that modernization led to the emergence of several new problems in urban life, including an exacerbation of the problem of waste management. At the same time the adjustment of the mechanism of Kharkiv rubbish disposal became an important sphere of activity of city authorities, businessmen and the public in the second half of the XIXth-beginning of the XXth century.

Lecture 18: Anti-stress in a modern way: medical and health recreational infrastructure of provincial towns of Left-bank Ukraine in the second half of XIX - beginning of XX century.

Lecturer: Khovtun Anastasia, Ph.D., Faculty of History, V. N. Karazin Kharkiv National University

"Anti-stress in a modern way: medical and health recreational infrastructure of provincial towns of Left-bank Ukraine in the second half of XIX - beginning of XX century".

The lecture is devoted to the formation of the recreational complex of Kharkiv, Poltava and Chernihiv. Modernization, besides the positive social and economic development of the cities, had negative consequences for the health of city-dwellers: increase of sanitary problems, ecological risks, mental and physical stress. At the same time, the development of medicine, hygiene and sanitation and the dissemination of this knowledge by educators have changed the attitude of city dwellers to their health. Being healthy became fashionable. The response of entrepreneurs, doctors and city authorities to this public demand was the formation of recreational infrastructure, which in the second half of the 19th century and the beginning of the 20th century included gardening areas, sports facilities, sanatoriums and preventive clinics.

Lecture 23: "Political posters and caricatures as means of ideological struggle in Ukraine during the Second World War"

Information technologies have become one of the tools of the Russian Federation's war against Ukraine. Taking into account the peculiarities of Donbas, the Russian propaganda machine generated special approaches to the processing of mass consciousness in the appropriate direction. A significant part of the ideological product, in particular in the visual information space of the occupied Donbas, is creolized forms that exploit the themes and style of posters of the German-Soviet war of 1941-1945. During the lecture, we set the task to find out the features of political technologies based on the exploitation of the Soviet ideological product of the Second World War in the context of Russian aggression against Ukraine and the temporary occupation of its territory.

Lecture 30: Names of hotels, restaurants and products as "double mirrors" of city symbols.

The mechanisms of symbolization of urban space have recently come more and more into the focus of attention of scientists. Understanding what exactly and for what reasons becomes a symbol, how this symbol functions, is necessary not only as a result of theorizing and practical observations of researchers, but also for successful branding of cities. It is also important to know how cities are seen by their residents or how they can be seen by potential visitors/tourists, how they are presented to Others. One of the means of symbolizing cities is the names of restaurants, hotels and products in several cities is the focus of this lecture. The names of trademarks and goods (pragmonyms), enterprises and organizations (ergonyms), undoubtedly, in a certain way reflect peculiarities of historical, industrial, cultural development of cities. We will look at typical nomination models and how they reflect the images of four Ukrainian cities before the invasion of the Russian Federation (Dnipro, Zaporizhzhia, Odessa, Kharkiv).
