#### **About the instructors**

#### Dr. Mehmet Penbecioğlu


Penpecioğlu is a city planner and urban politics scholar. He received his masters and PhD from the Middle East Technical University. He completed his postdoctoral research at TU Delft OTB. He was unlawfully expelled from his latest post at Izmir Institute of Technology. As an independent researcher, he is continuing to give lectures and to carry out research and publications in the fields of urban politics and local governments.

#### Dr. Ulaş Bayraktar

Bayraktar obtained his PhD degree from Institut d'Etudes Politiques de Paris in political science. He researched and published mainly on urban politics, local democracy and public policies. He was expelled from his public post at the Mersin University for being among the Petitioners for Peace. He is one of the founder-partners of Kültürhane.

### **Description of the course**

The course offers a comparative perspective of the field of urban politics. By comparing different theories and diverse practices, this course will introduce students to an analytical framework to understand urban politics and explain its underlying dimensions of political power and social struggle. It consists of two major interrelated parts: (1) Theoretical Foundations of Urban Politics and (2) Comparing the Practices of Urban Politics.



The first part covers the main theoretical discussions for urban politics. Classical urban theory, known as the Chicago School, puts forward a non-political, ecological and behavioural explanation of urban development. Urban regime analysis and growth machine conceptualization, on the other hand, concentrate on the role of political and civil society agents; manifests their collaborative relations and identifies urban coalitions. Based on a critical political-economy perspective, the structuralist Marxist approach originates from capital-labour contradiction and reveals the conflictual relations of state policies, collective consumption and urban social movements. Marxist Geography literature mainly indicates how the "production of built environment" becomes an integral strategy for the accumulation and circulation of capital. Lefebvrian conceptions of "urban revolution" and "production of space" open new ways for exploring "planetary urbanization".

Conceptual discussions during lectures 1-6 constitute the theoretical backbone in the first part of the course. In the second part, lectures 8-10 pay particular attention to practices of urbanism across the world, explaining their common political-economic trajectory and diverse settings of power relations. Lectures 11-13 are devoted to explain Turkish urban politics. These lectures set out the historical background and informal roots of Turkish urban politics; explain political dominance of mayors as a part of authoritarian neoliberal regime. The course is concluded by a final lecture on "City as Commons".

### Learning aims: What do you and the participants learn during the course?


- 1. Main theoretical foundations of urban politics (within a historical background and critical perspective)
- 2. Key practices of urban development and transformation (in diverse socio-political geographies of capitalism)
- 3. Comparison of different urbanism practices (and their meaning in terms of urban political theory)

### What do you expect from the participants?

- 1. Attend the online class: Lecturers expect participants to attend the online class and to come to this meeting prepared.
- 2. Read the main readings and watched video lectures before coming to the online meeting. It is also expected that participants be actively involvement in the meeting, formulating critical questions and discussing key issues based on each week's topics.
- 3. Weekly Reflection Papers: Lecturers expect participants to write down a one-page reflection paper after each week's online class. In this reflection paper, it is expected that participants discuss main concepts, make comments and formulate questions on specific topics by each week. (The evaluation of the participants' performance will be mainly based on this reflection papers.)

#### **Course organisation**

The course is organized as a 14 week program consisting of different topics in urban political theory and practice.

There are two mutually constitutive parts in the course: (1) Theoretical Foundations of Urban Politics and (2) Comparing the Practices of Urban Politics. In the first part, lecturers provide a critical analysis of urban theories in relation to their historical dimensions and political meanings. In the second part, we present and discuss key cases/practices of urban politics (including urban development and transformation, local government policies etc.) by establishing the analytical links with the theoretical background.

The course consists of video lectures, presentations, readings and online class discussions. For each week, lecturers and participants concentrate on a specific topic of urban political theory and practice. Presentations and discussions of these topics will be carried out through these lectures, readings and discussions. For some weeks, in addition to video lectures, participants will watch some documentaries, interviews (prepared by the lecturers) and films specific to each week's topic and provide a better understanding for the issues discussed.

### Detailed description of the course

The course is organized as a 14-week program. With the active involvement of the participants, lecturers present and discuss key topics in urban political theory and practice.




